

Europe Import Control System (ICS/ICS2) Fees

The European Commission recently implemented new regulations and will require electronic data to be submitted to European Import Control System (EU ICS) for all import shipments entering or transiting the EU. Since all Master Air Waybill (MAWB) and House Air Waybill (HAWB) information must be transmitted electronically to EU Customs, AA will require complete HAWB information at the time of acceptance. If the Shipper has been authorized to transmit electronic data and opts to transmit the information directly to EU ICS authorities, AA will not assess a fee. However, if the Shipper requests AA to transmit the electronic information and the HAWB data does not exist at the time of acceptance, a manual data entry fee will be assessed. These fees will be assessed at the origin for both online and interline shipments and will be applicable to all AA (001) Air Waybills that transit or terminate in the EU.

The following ICS fees will be assessed at origin for both online and interline shipments and will be applicable to all AA (001) Air Waybills. **Shipments requiring manual data entry that transit the U.S. to Europe will not be assessed a U.S. Customs and Border Protection (CBP) fee.**

- CG (EDI Processing): When the Shipper transmits FHL/2 information to AA and AA transmits to EU ICS
- CC (Manual Data Entry): When the Shipper presents documentation and AA manually inputs and transmits to EU ICS
