

U.S. Customs and Border Protection (CBP) Fees



U.S. Customs and Border Protection Agency (CBP) will require advance electronic data for all import shipments that transit or terminate in the United States. As a result, all Master Air Waybill (MAWB) and House Air Waybill (HAWB) information must be transmitted through Air Automated Manifest System (AMS). If the Shipper has been authorized to transmit data through Air AMS and opts to transmit the information directly to CBP, AA will not assess a fee. However, if the Shipper has not been authorized to transmit data to CBP, AA will assess a "CG" or "CC" fee as defined below (unless mandated otherwise by the local government). These fees will be assessed at the origin for both online and interline shipments and will be applicable to all AA (001) Air Waybills that transit or terminate in the United States.

- CG (EDI Processing): When the Shipper transmits FHL/2 information to AA and AA transmits to CBP
- CC (Manual Data Entry): When the Shipper presents documentation and AA manually inputs and transmits to CBP
