

Charges Collect Fees (FCC)



American Airlines will assess the following Charges Collect Fees (FCC) when an international shipment is tendered as a collect shipment and American Airlines is the final carrier (e.g., for on-line service). The FCC fees will be calculated as a percentage of the weight and valuation charges, and the fees may be converted at destination at the banker's rate of exchange. The FCC fees will be non-commissionable and must be paid by the Consignee. American Airlines surcharge amounts are based on the Air Waybill execution date (e.g., the Air Waybill date).
